### Background

- Pharmacists are often the first line of contact in rural communities
  - Example: Harman, WV
    - Pill Box Pharmacy in town
    - 22 miles (25 minutes) to nearest primary care office
- Recent expansions in pharmacist scope of practice in WV
- Working together with physicians, pharmacists can improve access to care for those living in rural areas









### The Purpose of this Research

- Assess physicians' understanding of the roles a pharmacist may have in patient care, as well as physician comfortability with pharmacists providing specific services
- Understand areas of opportunities for advocacy and collaboration

1 (3.6%) in Urgent Care


10 (35.7%) have been practicing for >21 years

**Entry Level Degree for a Pharmacist** 








### Doctor of Pharmacy Coursework

- Emphasizes written and oral communication skills, utilization of case studies, problem-based learning, and computer literacy
- Curriculum teaches a variety of hands-on skills such as patient counseling, physical assessment, and compounding.
- Advanced Pharmacy Practice Experiences, totaling 1440 hours or more, designed to prepare students for practice in fourth professional year
  - Settings: academic medical centers, community hospitals, diabetes clinics, academia, community pharmacies, and more!

#### **Board Certifications**

As of January 2021, more than 49,000 pharmacists obtained one or more certifications.

2023: 4,936 graduating pharmacy students pursued a residency




Knowledge of Services That Pharmacists Can Provide in WV

### Beyond the Pharmacy Counter

- Peter Kreckel, RPh (PA)
  - Nickman's Drugs, Adjunct Professor, Clinical Pharmacist at Empower 3
  - Completing FlipthePharmacy initiative, writes and distributes educational leaflets to local practices, developed "cheat sheets" for covered diabetes and COPD agents for particular insurance plans

### Beyond the Pharmacy Counter

- Nikki Shay, PharmD
  - Health Center Pharmacy (WV)
  - Provides education, dosage adjustments, and follow up with primary care providers on patients' warfarin therapy
  - Weekly appointments worked into her role as a community pharmacist





# Beyond the Pharmacy Counter

- Moundsville Pharmacy (WV)
  - Offers variety of services:
    - Medication synchronization
    - Medication packaging
    - Home delivery
    - Medication therapy management
    - Medicare Part D plan reviews



### Collaborative Practice Agreements

- Currently described in West Virginia Pharmacy Law
- Outline provided on WV Board of Pharmacy website for "how to" complete
- Pharmacists and providers must meet all requirements and standards



# Collaborative Practice Agreements: "Do's" and "Do Not's"

#### • Do:

- Allow physician to delegate with oversight
- Promote discussion regarding patient care between physician and pharmacist
- Aims to improve outcomes and access to care in rural areas
- Develop and maintain strong relationships between physicians and pharmacists

#### • Do Not:

- Allow a pharmacist to take over the physician's practice
- Exclude the physician from direct patient care
- Alter the structure of physicians' visits
- Aim to create animosity between the professions

# How to Identify Pharmacists for Collaboration:



Located in your area that you have the ability to communicate with frequently



Independent pharmacies



Believes in what you are doing to improve patient care



Willing to complete the steps necessary and create a collaborative agreement to fit your needs



# Requirements for Collaborative Practice

- A physician's eligibility may be verified through the Board of Medicine and Board of Osteopathic Medicine. Those able to collaborate must ensure that it remains within:
  - The medical scope and specialty of the physician's practice AND
  - The education, training, and experience of the pharmacist
- The Board of Pharmacy shall verify the pharmacist's eligibility and document that the pharmacist has the following:
  - One million dollars of professional liability
  - Meets one of the eligibility criteria
- May enter into collaborative practice in any setting
- Must complete practice notification with Board of Pharmacy



#### Improved Outcomes

INR Total Time in Range (71.4-84.6%)

Increase in the percentage of achieving therapeutic target HbA1c by 22-39%

Reduction in heart failure hospitalizations 9% Reduction in hospitalizations from asthma 30-75%
